Mr. Jackson,

I have read your 'Open Letter to the United States Senate'. Furthermore, I find your efforts to expose that enterprise and force it's proponents and functionaries toward exposure and accountability (both to the public and to targeted individuals themselves) to be a worthy and important effort for the ultimate benefit of the future of a free nation.

I continued my trips to Washington on other projects, one of which was a contract research project with the National Science Board on Technology Transfer. Just prior to that, there had been hearings on the MK-Ultra program involving the use of non-lethal weapons on civilians within the United States, especially dissenters. So I fit that profile because I had dissented from the suppression of this study.

I will recite three separate occasions on which I experienced non-lethal weapons of either an electronic or chemical form that were directed against my person. They were intentional intrusions.

I am talking about what in common parlance is called mind-control weapons. These are weapons of an electromagnetic nature which can be used against a target civilian which can stun them, be used to deter them, and which can be used to induce states of various panic and delusional states.

They are generally applied in an integrated fashion with ground personnel, such that, if you are a targeted individual, a dissident within the government or someone with knowledge that they want to keep private, they will target your profile. And they will use an electromagnetic weapon to affect your mind while you are surrounded by ground personnel in the form of agents to induce paranoia in you.

Enough of that and a person can be destabilized economically and can be destabilized from a health point of view. So I experience this in three separate instances following the termination of this project. The first instance was while I was on a contract research proposal trip to meet with an assistant secretary level person in the Pentagon. I was escorted in by an Officer of the Pentagon and I was brought into the anteroom of the Assistant Secretary and told to wait there. I was there in a professional capacity.

Across from me was seated a woman, I wasn't sure what she was, the Secretary of whatever. All of a sudden she takes a large placard and lifts it up like this and on this placard is a term calculated in the mind-control technology to induce what is called "cognitive dissonance", to shake up the target. On that placard was written in large letters, "S-E-X".

Because of my years of research in this area I knew exactly what was taking place. I was being tele-guided into a mind-control for the purpose of destabilizing me so that when I met with the Assistant Secretary I would be more shaken up - and if I told this tale I would be discredited, because how could this happen within the halls of the Pentagon?

Fortunately from my research, I knew exactly what was happening and I didn't panic, I just sat there and endured that episode. The subsequent episodes became more serious. I was on my way back to Palo Alto and stopped in New Orleans to see a brother of mine, but 'also had an appointment with Judge Jim Garrison on issues having to do with the House Select Committee on Assassinations in which the Chairman, Heary D. Gonzalez, had appointed me one of the public watchdogs.

My meeting with the Judge was at the New Orleans Athletic Club on a Sunday morning and on Saturday I went with my brother to visit the King Tut exhibit and all of a sudden I got physically ill. I went into massive hallucinations. I was disoriented. I was forced to change my schedule. I could not meet with the Judge and I could barely make it back to the airplane Sunday night to go back to Palo Alto. When I went to the airport I was surrounded by covert ground personnel, dressed in suits, like agents.

I knew from my professional research in the mind control area that these are mind-control personnel calculated to come in on a targeted individual in a weakened condition and induce paranoia and destabilize that individual. Fortunately, because of my research, I was able to continue to Palo Alto and make it through this experience although it was very trying.

I went to the Pentagon and I was hit. I got on the airplane to New Orleans and I was hit again. Then, I got back to Stanford Research Institute and I was hit. It was as though the order had been given out to take me out after the proposal had been terminated.

[Would it make sense to give a cad security clearance and access to the most powerful technologies? No. Occam would suggest that they feel free to attack people for reasons other than crime or morality.]

Sci-Fact – Not Fiction: High-Tech Slavery Is Here **By Maitefa Angaza**

Following the hospital incident, it quickly became apparent to Wronge that something was terribly amiss. He **experienced a host of physical disturbances, including dizziness, nausea, incontinence and headaches, along with an inability to sleep.** He was suspicious that his body had somehow been tampered with.

Some of his symptoms abated over the next few years, Wronge said, but he claims that curious things continue to happen sporadically. At times he would **hear a mechanically-sounding voice in his ears repeatedly saying things like “Your mother doesn’t love you” or “Your entire family will be killed.”** At other times he suddenly would begin to perspire profusely for no apparent reason.

...

Wronge took the opportunity of being back at Elmira to do some investigating. “Because I worked as an inmate liaison, I had access to the grievance committee files.” He said, “I saw several documents detailing complaints from inmates about the discomfort they were experiencing in their ears and oral pharynx – that is, the area at the back of the throat. They had sense enough to know that something had been done to them, but almost uniformly, they were sent to the ‘satellite unit,’ an area of isolation supposedly for mentally unstable inmates.”

Armed with the knowledge that he was not alone in his suspicions, Wronge began looking into his own case immediately upon his release. He went to see Dr. Albert O. Duncan, a physician acquainted with his brother, who wrote him a prescription for MRI – a type of X-ray.

Diagnostic Imaging Associates, a Brooklyn lab, reported back: “MRI of the chest was performed. These images reveal the presence of a paramagnetic foreign body artifact noted in the region of the left anterior chest wall at the level of the axilla.”

The resulting report from MRI-CT Scanning Inc. revealed: “The bilateral external auditory canals demonstrate dense rectangular shaped metal foreign objects. The etiology of this finding is uncertain. Clinical correlation is suggested.”

The physician, who wishes to remain anonymous at this time, looked into Wronge’s ears with an otoscope and allowed Valentine to look also.

The **doctor reports seeing “a flat metallic object, like a computer chip, covering a portion of his eardrum.** Where I should have been able to see straight through to his entire eardrum, this object was obstructing my view. It was a little off to the side like a snare drum.”

When asked what the purpose of positioning a computer chip in that location would be, the doctor replied, “To pick up and transmit sound. **With a device in that location one could hear what is said to a person and have them hear what you might say to them.**”

The anatomist, at the suggestion of Velentine, then asked the videographer for use of a hand-held microphone. “**When I passed the microphone over his body, it picked up vibration and ‘white noise’** – sound waves that would be emitted by computer chips.” The doctor said. “This happened in the area under his arm, near his forehead and in some places along the vertebral column.

“**When we had been doing this for a minute or so, the sound suddenly dropped as though someone had turned down the frequency somewhere.** These chips are probably operated by some transmitter station that the body senses sound waves out to.”

The doctor feels it is, of course, obvious that a medically trained person did this. “They know where the rootlets come out of the spinal cord, and the underarm was chosen because it is located along the channel where the nerves come out of the tracheal plexus and go into the arm. **There is a heavy enervation there with electrical impulses and neuronal transport impulses. Something artificial could easily interfere with the current, producing a human radio.**”

About Wronge’s X-rays, the doctor said, “There are certain sinuses in the bone, grooves where something is implanted in the maxillary area.”

This would enable someone on the other end of a microwave transmission to monitor Wronge’s speech and even thoughts, said the doctor. Our thoughts are registered in very high-pitched frequency on the voice box. “Remember that saying, ‘You can’t go to jail for what you think’? Well, not anymore, “ said the doctor.

[According to Wronge] “That second-class mentality that feels that nothing is legitimate until it has been validated by the government or the mainstream media is suicidal. They prepare us for these types of things by putting them in movies like Total Recall, where Arnold Schwarzenegger discovers he’s been implanted and removes the device through his nose. Then, when they gradually make the public aware that these things exist, we are supposed to think, ‘Oh, that’s OK. That’s a technological advance. I saw it in the movies.’

Charles Schlund vs George W. Bush verified complaint signed under oath per Federal Rules of Civil Procedure, Rule 11

The Ninth Circuit Court of Appeals' clear understanding that the sophisticated and complex electronic surveillance and other electronic [devices] can be 'used in tandem with surveillance technologies' and 'other electronic devices' or 'other sophisticated electronic surveillance devices ought not be permitted in a free society.'" (Id. Koyomejian)

The Supreme Court has issued prior decisions which support the issuing of injunctive relief for Plaintiff Schlund which involve a wide range of scientific and other electronic force technologies admittedly used not only by the United States Government, but others as well. See, Central Intelligence Agency v. John Cary Sims and Sidney M. Wolfe, 471 U.S. 159, 85 L Ed. 2d 185 S.Ct. 1881 (1965).

In the case before the bench, Plaintiff Schlund has been and is pretextually and judicially branded as a criminal and was set-up by sloppy, dirty, and corrupt government agents who got caught by the Honorable Federal Judge Lacey who held they committed "outrageous" acts of fabrication of evidence, witness tampering, obstruction of justice and other severe and repetitive acts of immoral and grossly unethical conduct under color of authority and office. The officials themselves were radical and uncivilized criminals violating federal law. They should have been jailed.

The Honorable Federal Judge Lacey after acquitting plaintiff while standing and beating on his desk demanded that the corrupt federal agents be arrested for perjury and yelled that no one commits perjury in his court.

The corrupt agents nearly ended up in jail themselves on sua sponte contempt charges vigorously voiced on bedrock of anger by United States District Court Judge Lacey. The judge's clear expressions were in essence that the corrupt and dirty cops were the actual criminals not Plaintiff Schlund who was merely painted as a criminal in the bogus and fabricated proceedings marshaled against him by the DOJ and DEA. Plaintiff Schlund's statements have been consistently reliable for over twenty-five (25) years since he was acquitted. Government won't send files ordered by Court on electronic weapon

Despite the fact that a murder attempt was made on his biological father and his adopted father was murdered, a Napa man is challenging the United States government.

Donald M. Friedman is concerned about use of the Secret Service and any other government agencies using directed energy weapons systems on civilians. He has filed several requests for documents from the government under the Freedom of Information Act (FOIA) concerning directed energy weapons, which the Pentagon claims are legal under international law. Human rights groups are arguing that the weapons could be used inhumanely.

The devices can affect the human body. Millimeter waveband energy can penetrate human skin to a very shallow depth, heating the tissue below. This produces a burning pain without actually damaging the tissue. The pain forces the person to flee the area. This type of weapon, according to published reports, shows great potential as a riot-control device or area-denial system.

The IEE International Symposium on Technology and Society in 1997 states, “The development of high-power microwave weaponry, and its proliferation into subversive organizations, offers the means to commit the ‘perfect crime’. “ The weapon “attacks typically leave no residual evidence and their effects can range from nuisance to catastrophic.

Friedman has been shoved from pillar to post by the federal government – from denial that such weaponry exists to stalling on the release of any material. In fact, in an attempt to cause a roadblock, the federal government asked for \$3828.28 in advance to gather the material. Friedman paid the money and still no documents.

Finally, Friedman took the issue to federal court. The federal government asked for delay after delay. Finally, **Judge Richard W. Roberts, a United States District Judge ordered the United States Secret Service to provide the documents requested by Friedman by July 20, 2007. July 20 has come and gone and the Secret Services still failed to comply with the United States District Court order. No explanation was given for not providing the documents – just total silence. Friedman is now filing contempt of court actions against the Secret Service and seeking sanctions.**

Montreal Court Case Nabs CIA for Illegal Mind-Control Experimentation

More than 250 unsuspecting patients eligible for compensation, according to Canadian ruling. **Critics of CIA-funded mind control programs call attention to the fact they are still going on today, as referenced in declassified documents calling attention to sinister operations called Bluebird/Artichoke and MKULTRA.**

A barbaric CIA-backed brainwashing experiment, used on innocent people, was at the bottom of a Montreal court decision last year, allowing 250 patients the right to seek compensation for unwillingly taking part in a sinister mind-control program.

The little known Canadian case was given hardly any attention in the American press, but provided startling evidence that as far back as 1953, the American government was covertly involved in funding devious experimental mind control techniques developed by Nazi scientists.

In court documents, Kastner stated:

“Patients were awakened from drug-induced stupors three or four times a day and given numerous electro-shock treatments,” Kastner said, adding Dr. Cameron placed patients in specially designed sleep rooms, **placing speakers under pillows in order to relay negative messages at least 16 hours a day.**

Court documents revealed Kastner was a 19-year-old gifted honor student when she underwent the treatment at Alan Memorial Institute under Dr. Cameron’s direction, treatment designed to alter her personality not cure her depression.

Testimony also revealed when Kastner returned home after her treatment in 1953, she had drastically changed into a completely different person, demonstrating bizarre-like childish behavior.

Her behavior which included talking in baby-like sounds, urinating on the floor and demanding to be fed from bottle finally led to the break down of her marriage and being totally abandoned by her wealthy family who could no longer cope with her behavior. The case uncovered Dr. Cameron with CIA money and Nazi technology developed a method to deprogram a person’s behavior similar to the techniques portrayed in the novel Manchurian Candidate, where people were brainwashed and reprogrammed to carry out specifically assigned tasks.

Critics of CIA involvement in torture and mind-control experimentation are pointing to this case as proof-positive that illegal brainwashing programs are still

being carried out in America, the mild-altering techniques being used on unknowing and unwilling Americans for many different types of covert activities.

And dating back to the 1950's the CIA has a long and storied involvement with mind control techniques, essentially being documented by more than 18,000 declassified pages of CIA documents on mind-control.

However, even though the numerous declassified documents are revealing, researchers suggest much of the more ruthless actions have been deleted from the record prior to the Freedom of Information Act release of the documents.

One of the documents released dated Jan. 7, 2005, explained the following activity being performed on two young women:

“With a section heading “Outline of Special H Cases” it describes the experimental creation of multiple personality in two 19-year old girls by the CIA. “H” is used as shorthand for hypnotic, hypnotized, or hypnotism in these documents: “These subjects have clearly demonstrated that they can pass from a fully awake state to a deep H controlled state by telephone, by receiving written matter, or by **the use of code, signal, or words, and that control of those hypnotized can be passed from one individual to another without great difficulty.** It has also been shown by experimentation with these girls that they can act as unwilling couriers for information purposes.”

[‘Hypnotism’ can take the form of an endless bombardment of suggestion, chastisement, ridicule, negativity over years of time to the fully conscious mind. – Ted Jackson]

Another even more incriminating CIA declassified document revealed the following evidence of mind control used to turn people into assassins like depicted in the movie Conspiracy Theory starring Mel Gibson:

“A declassified CIA document [8] “Hypnotic Experimentation and Research, dated February 10, 1954,” describes a simulation of relevance to the creation of unsuspecting assassins: “Miss [left out] was instructed (having previously expressed a fear of firearms in any fashion) that she would use every method at her disposal to awaken Miss [left out] (now in a deep hypnotic sleep). Failing this, she would pick up a pistol nearby and fire it at Miss [left out].

“She was instructed that her rage would be so great that she would not hesitate to “kill” [left out] for failing to awaken. Miss [left out] carried out these suggestions to the letter including firing the (unloaded) gun at [left out] and then proceeded to fall into a deep sleep. Both were awakened and expressed complete amnesia for the entire sequence. Miss [left out] was again handed the gun, which she refused (in an awakened state) to pick up or accept from the operator. She expressed absolute denial that the foregoing sequence had happened.”

Also of interest is the experience of mind-control victim, Carol Ruiz, author of the book *A Nation Betrayed*. In excerpts from her book, Rutz said:

“The CIA bought my services from my grandfather in 1952 starting at the tender age of four. Over the next 12 years, I was tested, trained, and used in various ways. Electroshock, drugs, hypnosis, sensory deprivation, and other types of trauma were used to make me compliant and split my personality (create multiple personalities for specific tasks). Each alter or personality was created to respond to a post-hypnotic trigger, then perform an act and not remember it later. This “Manchurian Candidate” program was just one of the operational uses of the mind control scenario by the CIA. Your hard-earned tax dollars supported this.

“As a survivor of CIA programs Bluebird/Artichoke and MKULTRA, I began my intense search to document some of the mind control experiments that I was made part of. Through a series of FOIA requests to various departments of the government, 48 years after I was first experimented on, I found solid proof of my memories—proof that was in the government vaults of the nearly 18,000 pages of declassified documents from the Bluebird/Artichoke and MKULTRA programs.

“One of the declassified documents states, ‘Learning studies will be instituted in which the subject will be rewarded or punished for overall performance and reinforced in various ways—with electric shock, etc. In other cases, drugs and psychological tricks will be used to modify attitudes. The experimenters will be particularly interested in dissociative states (multiple personality). An attempt will be made to induce a number of states of this kind, using hypnosis.’ The government had finally handed me the validation I had been searching for.”

Implant Victim Refused Help by 'Humanitarian' Physicians By Roger Hutcheon The City Sun Newspaper

The Boston chapter of PHYSICIANS FOR HUMAN RIGHTS (PHR) last month refused to examine or treat government implant victim Brian Wronge, against the protest of some of its members.

Further examination revealed miniature radios implanted in the membrane of Wronge's eardrums, according to a research biologist who examined Wronge with an OTOSCOPE. Use of such radio implants by CIA-funded experiments had been rumored since the 1960's, when individuals testified that institutes in UTAH had been using them on prisoners in that state without the victims' knowledge.

Requests through the Freedom of Information Act to obtain documents on the UTAH experiments, to this date, have not been complied with.

A federal Eastern District Court Judge, Justice REENA RAGGI, has Wronge's lawsuit against the state of New York pending, instructing Wronge to find a surgeon to remove one of the implants. However, in the three years since the May 1991 lab reports, no surgeon would remove the implants, usually citing FBI RETALIATION as the reason.

On July 21, a staff member stated, "No one here is allowed to speak with you. I was told to say that," mentioning that the director gave the silence order prior to a vacation.

The tense atmosphere at PHR following the Wronge denial was also evident among board members who refused to discuss details of the behind-the-scenes dialogue, although two of them revealed through various conversations that they were subjected to INTENSE CAMPAIGNING BY COLLEAGUES NOT TO SUPPORT PURSUIT OF THE ISSUE. Dr. CAROLA EISENBERG, vice president of PHR, was eager to help Wronge in late April but, in May, was discouraged from doing so after a conversation with STOVER.

The PHR decision was highly controversial, considering the group's documented statement of purpose - the basis on which it is supported by their large MEMBERSHIP. The statement includes the following mandates:

Since PHR's inception in 1986, it repeatedly has rejected suggestions to address medical misconduct by government agencies. "We may have a case of a group that is not pursuing the very issues its membership is MAKING LARGE CONTRIBUTIONS to see rectified," said one member of the Boston group.

Former NSA Employee John St. Clair Akwei vs. NSA Ft George G. Meade, MD

**Evidence for the Lawsuit filed at the US courthouse in Washington, D.C.
(Civil Action 92-0449)**

My knowledge of the National Security Agency's structure, national security activities, proprietary technology, and covert operations to monitor individual citizens.

A subject's bioelectric field can be remotely detected, so subjects can be monitored anywhere they are. With special EMF equipment NSA cryptologists can remotely read evoked potentials (from EEGs). These can be decoded into a person's brain-states and thoughts. The subject is then perfectly monitored from a distance.

NSA personnel can dial up any individual in the country on the Signals Intelligence EMF scanning network and the NSA's computers will then pinpoint and track that person 24 hours-a-day. The NSA can pick out and track anyone in the U.S.

NSA Signals Intelligence uses EMF Brain Stimulation for Remote Neural Monitoring (RNM) and Electronic Brain Link (EBL). EMF Brain Stimulation has been in development since the MKUltra program of the early 1950's, which included neurological research into "radiation" (non-ionizing EMF) and bioelectric research and development. The resulting secret technology is categorized at the National Security Archives as "Radiation Intelligence," defined as "information from unintentionally emanated electromagnetic waves in the environment, not including radioactivity or nuclear detonation."

For electronic surveillance purposes, electrical activity in the speech center of the brain can be translated into the subject's verbal thoughts. RNM can send encoded signals to the brain's auditory cortex thus allowing audio communication direct to the brain (bypassing the ears). NSA operatives can use this to covertly debilitate subjects by simulating auditory hallucinations characteristic of paranoid schizophrenia.

Without any contact with the subject, Remote Neural Monitoring can map out electrical activity from the visual cortex of a subject's brain and show images from the subject's brain on a video monitor. NSA operatives see what the surveillance subject's eyes are seeing. Visual memory can also be seen. RNM can send images direct to the visual cortex, bypassing the eyes and optic nerves. NSA operatives can use this to surreptitiously put images in a surveillance subject's brain while they are in R.E.M. sleep for brain-programming purposes.

There has been a Signals Intelligence network in the U.S. since the 1940's. The NSA, Ft. Meade has in place a vast two-way wireless RNM system which is used to track subjects and non-invasively monitor audio-visual information in their brain. This is all done with no physical contact with the subject. RNM is the ultimate method of surveillance and domestic intelligence. Speech and 3D sound, and subliminal audio can be sent to the auditory cortex of the subject's brain (bypassing the ears) and images can be sent into the visual cortex. RNM can alter a subject's perceptions, moods, and motor control.

Speech cortex/auditory cortex link has become the ultimate communications system for the intelligence community. RNM allows for a complete audio-visual brain-to-brain link or brain-to-computer link.

Electronics Today SMIRNOV

Women peace campers at Greenham Common, England, claimed that they were attacked by US electronic weapons from within the US airbase there. **Scientists from Electronics Today measured some form of electromagnetic wave that was responsible for illnesses they suffered. A team of doctors from the Medical Campaign Against Nuclear Weapons compiled a report on the condition of the women affected. The women first noticed a pattern of illnesses emerging in 1984. Women at different points around the camp appeared to have experienced similar symptoms at the same time, even when they were not in contact with one another.** Large numbers of women complained of sudden feelings of extreme tiredness shortly before major events, such as the departure of a cruise missile convoy. Readings taken with a wide range signal strength meter showed marked increases in the background signal level near one of the women's camps at a time when they claimed to be experiencing ill effects, including vertigo, retinal bleeding, burnt face (even at night), nausea, sleep disturbances, palpitations, loss of concentration, loss of memory, disorientation, severe headaches, temporary paralysis, faulty speech co-ordination, irritability and a sense of panic in non-panic situations, and in one case, a circulatory failure that required emergency treatment. Many of these symptoms have been associated in medical literature with exposure to microwaves and especially through low intensity or non-thermal exposures. **These effects have been reviewed by Dr. Robert Becker, twice nominated for the Nobel Prize, and a specialist in EM effects. His report confirms that the symptoms mirror those he would expect to see had microwave weapons been deployed.** (Guyatt)

British Defense officials have denied that any form of electronic signal was being used against the protesters.

VINCENT MICHAEL MARINO vs Gammel et al

[*248] 33. On or about the 28th day of November 1996, at approximately 12:32 a.m. Plaintiff was admitted for a 3rd time at the Massachusetts General Hospital Emergency Room, suffering from severe Abdominal Infection and high fever.

34. Plaintiff was examined by attending trauma physician, JONATHAN N. ADLER, M.D., who ordered, and caused to be carried out, X-rays of Plaintiff.

37. Radiologists RIEUMONT and KIM conducted x-rays of Plaintiff, the results of which were received by Plaintiff, through Collateral Litigation, and showed the following:

(A). No definite Pneumonia.

(B). On the lateral view, there is a "linear opacity" in the abdomen which most likely represents and "artifact".

40. At approximately 10:00 a.m. while exiting the Logan International Airport, the Plaintiff was confronted by several gun wielding individuals, claiming to be law enforcement agents.

41. Plaintiff was forced to lie down where he was searched, handcuffed and placed into custody by these agents.

42. Defendants GAMMEL, FARLEY, ROBERTO, KELLY, PETERSON, DESMOND, CUNIFF, SOILES, QUIGLEY and several JOHN DOES AND JANE DOES, took part in the arrest of Plaintiff stated in paragraphs number forty (40) and forty-one (41) above.

43. While in the custody of agents, Plaintiff was approached by Defendant ROBERTO, who attempted to gain Plaintiff's authorization and signature on a document.

44. The document stated in paragraph forty-three (43) above was purporting to be an "authorization" for the surgical removal of an electronic device from Plaintiff's body.

45. Defendant [**9] ROBERTO, informed Plaintiff, that Plaintiff had been implanted with an "a microchip tracking device" and law enforcement (Drug Enforcement Agency/Federal Bureau Investigation) had been tracing Plaintiff since on or about November 25, 1996.

46. Defendant ROBERTO, further stated to Plaintiff that it was on "on loan" to Drug Enforcement Agency from the Central Intelligence Agency (C.I.A.) and was a sophisticated state of the art piece of equipment, cost a lot of money. Must be returned to the CIA.

47. Defendant ROBERTO, assured Plaintiff that he (Plaintiff) would be released on bail if Plaintiff would [*249] sign documents and consent to surgical removal of device.

48. Plaintiff refused to sign the consent forms. Defendant DESMOND stated "Nobody will ever believe we did this".

50. While being transported from the Logan International Airport to the field office, Defendant's FARLEY, and QUIGLEY, continued to entice Plaintiff to consent to the surgical [**10] removal of the device.

51. Upon arrival at the Field Office, Defendant FARLEY, directed Plaintiff's attention to an office door within the Field Office building that displayed the name plate of one "Dr. STEIN."

52. Defendant FARLEY, advised Plaintiff that Dr. STEIN was the individual responsible for conduction, or causing to have conducted, the surgical implantation of the device, in Plaintiff.

53. While at the Field Office, Plaintiff was subjected to identification process (i.e. Finger printing, Photographs, etc...). While there Defendant SOILES stated "The implant in you, the devices capabilities are tracking and listening. We used the Massachusetts General Hospital Medical Doctors and Nurses and our own physician to do a clean implant while you were under General Anesthesia". Defendant JOHN GAMMEL agreed and said we knew where you were from Boston to Nevada to Arizona. State of the Art Device.

54. Upon the completion of identification process Plaintiff was transported to the Braintree Police Station (Braintree) for housing. Defendants: DEA Agents; KELLY & PETERSON Transported Plaintiff and [**11] also tried to convince plaintiff to consent to removal of Device.

55. While being taken from the Field Office to a vehicle for transportation to Braintree, one of the Principal Defendant's (possibly Defendant CUNIFF), informed Plaintiff that, "He (Plaintiff), was the only person with the device on the East Coast" and went on to mention another person implanted with the device on the "West Coast".

56. During the discussion stated in paragraph number fifty-five (55), above this Defendant further mentioned the source of "device" as the Central Intelligence Agency.

[*250] 61. During the Bond Hearing stated in paragraph number sixty (60) above; Defendant FARLEY, testified that he heard the conversation at Logan International Airport between Defendant Roberto, and the Plaintiff in which Defendant ROBERTO, informed Plaintiff about the Plaintiff being implanted with a "device" which monitored Plaintiff activities.

62. Defendant FARLEY, further testified that it was his belief that ROBERTO, was merely joking with the Plaintiff regarding the "device".

63. Upon adjournment of the January 6th Bond Hearing Plaintiff was returned to the Central Falls Facility for housing.

64. On June 14, 1999, a hearing was conducted (without the presence of Plaintiff) at the Federal Court Building Worcester, Massachusetts before the Honorable NATHANIEL M. GORTON, U.S. District Court Judge, at which time Judge GORTON, ordered Assistant U.S. Attorney's JEFFREY AUERHAHN, and CYNTHIA YOUNG, to ascertain whether or not agent's discussed a device being implanted in Plaintiff, and whether such implantation did occur.

65. As a result of Judge [**13] GORTON'S, June 14th Court Order the record reflects that certain Defendant's did in fact advise Plaintiff that a device was implanted in him, however, these Defendants were allegedly joking and there was no implantation of such device in Plaintiff.

66. On the 25th day of May, 2000, the Honorable JOSEPH TAURO, United States District Judge, ordered the government to cause to be affected and M.R.I. on Plaintiff to conclusively ascertain the existence of any electronic device implanted in the Plaintiff.

67. Judge TAURO's, May 25th Judicial order stated in paragraphs number 66 above, has to this date not been effectuated.

68. Plaintiff was under Federal/State investigation and surveillance, and monitoring at the time of and prior to Plaintiff's admission at Massachusetts General Hospital for gunshot wound.

69. As a product of discovery process conducted in a malpractice lawsuit against Massachusetts general Hospital, et al. (Case No: 99-5655H), Plaintiff has procured conclusive medical evidence that there did exist a foreign "artifact" inside Plaintiff at time of x-rays conducted at Massachusetts General Hospital, as set forth in paragraph [**14] numbers 36 and 37 above. This device remains inside Plaintiff.

The federal defendants assert that plaintiff's claim accrued on December 15, 1996, (more than two years before plaintiff initiated this civil action) when Defendant [**23] Roberto informed plaintiff that "a microchip tracking device" was implanted in plaintiff, and requested plaintiff's authorization for its removal. The court, however, cannot at the same time credit federal defendants' assertion that plaintiff's claim about the planting of a "microchip tracking device" is frivolous and credit federal defendants' assertion that at the time of that incident plaintiff knew or should have known "the fact of injury" to the plaintiff.

New on the Internet: a community of people who believe the government is beaming voices into their minds. They may be crazy, but the Pentagon has pursued a weapon that can do just that.

IF HARLAN GIRARD IS CRAZY, HE DOESN'T ACT THE PART...

"It's undeniable that the technology exists," Girard says, "but if you go to the police and say, 'I'm hearing voices,' they're going to lock you up for psychiatric evaluation."

HARLAN GIRARD SAYS HIS PROBLEMS BEGAN IN 1983, while he was a real estate developer in Los Angeles. The harassment was subtle at first: One day a woman pulled up in a car, wagged her finger at him, then sped away; he saw people running underneath his window at night; he noticed some of his neighbors seemed to be watching him; he heard someone moving in the crawl space under his apartment at night.

Girard sought advice from his then-girlfriend, a practicing psychologist, whom he declines to identify. He says she told him, "Nobody can become psychotic in their late 40s." She said he didn't seem to manifest other symptoms of psychotic behavior -- he dressed well, paid his bills -- and, besides his claims of surveillance, which sounded paranoid, he behaved normally.

...

In 2002, the Air Force Research Laboratory patented precisely such a technology: using microwaves to send words into someone's head. That work is frequently cited on mind-control Web sites. Rich Garcia, a spokesman for the research laboratory's directed energy directorate, declined to discuss that patent or current or related research in the field, citing the lab's policy not to comment on its microwave work.

Dennis Bushnell, chief scientist at NASA's Langley Research Center, tagged microwave attacks against the human brain as part of future warfare in a 2001 presentation to the National Defense Industrial Association about "Future Strategic Issues."

"That work is exceedingly sensitive" and unlikely to be reported in any unclassified documents, he says.

...

One TI from California conducted about 50 interviews, narrowing the symptoms down to several major areas: "ringing in the ears," "manipulation of body parts," "hearing voices," "piercing sensation on skin," "sinus problems" and "sexual attacks."

...

Gloria Naylor, a renowned African American writer, seems to defy many of the stereotypes of someone who believes in mind control. A winner of the National Book Award, Naylor is best known for her acclaimed novel, *The Women of Brewster Place*, which described a group of women living in a poor urban neighborhood and was later made into a miniseries by Oprah Winfrey.

But in 2005, she published a lesser-known work, *1996*, a semi-autobiographical book describing her experience as a TI. "I didn't want to tell this story. It's going to take courage. Perhaps more courage than I possess, but they've left me no alternatives," Naylor writes at the beginning of her book. "I am in a battle for my mind. If I stop now, they'll have won, and I will lose myself."

...

SOME TIS, SUCH AS ED MOORE, A YOUNG MEDICAL DOCTOR, take a slightly more skeptical approach. He criticizes what he calls the "wacky claims" of TIs who blame various government agencies or groups of people without any proof. "I have yet to see a claim of who is behind this that has any data to support it," he writes.

Nonetheless, Moore still believes the voices in his head are the result of mind control and that the U.S. government is the most likely culprit. Moore started hearing voices in 2003, just as he completed his medical residency in anesthesiology; he was pulling an all-nighter studying for board exams when he heard voices coming from a nearby house commenting on him, on his abilities as a doctor, on his sanity. At first, he thought he was simply overhearing conversations through walls (much as Waugh's fictional alter ego first thought), but when no one else could hear the voices, he realized they were in his head. Moore went through a traumatic two years, including hospitalization for depression with auditory hallucinations.

"One tries to convince friends and family that you are being electronically harassed with voices that only you can hear," he writes in an e-mail. "You learn to stop doing that. They don't believe you, and they become sad and concerned, and it amplifies your own depression when you have voices screaming at you and your friends and family looking at you as a helpless, sick, mentally unbalanced wreck."

...

A WEEK BEFORE THE TIS RALLY ON THE NATIONAL MALL, John Alexander, one of the people whom Harlan Girard holds personally responsible for the voices in his head, is at a Chili's restaurant in Crystal City explaining over a Philly cheese steak and fries why the United States needs mind-control weapons.

A former Green Beret who served in Vietnam, Alexander went on to a number of national security jobs, and rubbed shoulders with prominent military and political leaders. Long known for taking an interest in exotic weapons, his 1980 article, "The New Mental

Battlefield," published in the Army journal Military Review, is cited by self-described victims as proof of his complicity in mind control. Now retired from the government and living in Las Vegas, Alexander continues to advise the military. He is in the Washington area that day for an official meeting.

...

According to Alexander, the military and intelligence agencies were still scared by the excesses of MK-ULTRA, the infamous CIA program that involved, in part, slipping LSD to unsuspecting victims. "Until recently, anything that smacked of [mind control] was extremely dangerous" because Congress would simply take the money away, he said.

Alexander acknowledged that "there were some abuses that took place," but added that, on the whole, "I would argue we threw the baby out with the bath water."

But September 11, 2001, changed the mood in Washington, and some in the national security community are again expressing interest in mind control, particularly a younger generation of officials who weren't around for MK-ULTRA. "It's interesting, that it's coming back," Alexander observed.

...

Alexander also is intrigued by the possibility of using electronic means to modify behavior. The dilemma of the war on terrorism, he notes, is that it never ends. So what do you do with enemies, such as those at Guantanamo: keep them there forever? That's impractical. Behavior modification could be an alternative, he says.

"Maybe I can fix you, or electronically neuter you, so it's safe to release you into society, so you won't come back and kill me," Alexander says. It's only a matter of time before technology allows that scenario to come true, he continues. "We're now getting to where we can do that." He pauses for a moment to take a bite of his sandwich. "Where does that fall in the ethics spectrum? That's a really tough question."

When Alexander encounters a query he doesn't want to answer, such as one about the ethics of mind control, he smiles and raises his hands level to his chest, as if balancing two imaginary weights.

Cheryl Welsh

Cheryl Welsh, director of Cahra (Citizens Against Human Rights Abuses), listed as one of six Non-Lethal Weapons Experts in the world in UNIDIR, United Nations Institute for Disarmament Research 2002 Media Guide to Disarmament in Geneva. Cheryl Welsh coordinates efforts by victims and supporters to end oppressive mind control activities. In her account, Cheryl tells how she has been a victim since 1989.

"I would like to prevent victims from experiencing much of the pain that I went through by telling my testimony within the framework of background information and history on government weapon testing programs, especially radiation experimentation."

UNIDIR Media Guide to Disarmament cited Cahra and my article in which I discuss mind control technology and weapons which target the brain, and illegal experimentation. A 2001 Model UN also cited my article. One of Cahra's goal will be to work on a coalition to ban mind control weapons and nonconsensual experimentation, as blinding lasers were banned.

Harlan E. Girard

Director of the International Committee for the Convention against Offensive Microwave Weapons

Harlan E. Girard was born in Cleveland , Ohio in 1936. He studied for the B.Chem.E. degree at Cornell University and received the B.A. degree in economics from The University of Michigan, Ann Arbor, from which he graduated in 1957. From 1957 to 1984, Mr. Girard was employed and self-employed in a number of businesses, all of them centered on real estate development. In 1984, he returned to school to study urban design and landscape architecture at the University of Pennsylvania, from which he received the Master of Landscape Architecture degree in 1988. Since 1988, Mr Girard has been pursuing independant research into the development, testing and evaluation of offensive microwave weapons, including especially mind-control mechanisms. He is an Associate Member of The Institute of Electrical and Electronic Engineers, a member of the Society of Photo-Optical Instrumental Engineers(SPIE), an Associate Member of the Bioelectromagnetics Society, and an Associate Member of the European Bioelectromagnetics Association. In 1990, Mr Girard established the Interantional Committee for the Convention Against Microwave Weapons for the purpose of continuing his work, in the event of his untimely death. The International Committee has an arms control function but it is also interested in the atrocities being committed by the United States Government (USG) in the research, development, testing and evaluation of biological process control weapons. In addition, It is interested in the USHG's compliance with the conventions to which it is a State Party, such as the Convention Against Torture. The International Committee contends that involuntary human medical experiments financed by any government are punishment per se, and the infliction of gratuitous pain and suffering on involuntary human subjects is torture within the meaning

of this Convention. Mr Girard received an Honorable Discharge from the United States Air Force in 1963, and used to be a moderate Republican.

My son has also said he heard them, but I'm not sure if he's going along with me on this one. The strange events started happening at the start of 1998. I was sitting in my cubical at work and the voices, which I have heard in the back yard seem to be at work. At first, I thought I was imagining this, but it seems that there were other voices too. I heard two male voices and one female's voice. I also thought I was experiencing a nervous breakdown or going crazy, as some would say.

I'm a victim, I want to share my observations of the way this group is currently using this weapon. They seem to be able to image through walls and can aim this weapon. They usually wait until something productive is undertaken--like reading, computer use or other things that utilize the mind. The emission burns the skin, and damages the eyes. The stomach pains created from exposure cause horrible cramps and terrible gas. They use the weapon especially at night to disrupt sleep. This is an emission, you'll know your being targeted rightaway by the noises it makes when it strikes near you. You can literally hear it hitting the walls, tv whatever. It is very painful when it strikes the skin. There seems to be a coordinated group involved, and they take extreme care in covering up there actions. They use the police!!!

Jas

For nealy a decade I have suffered almost daily mental / physical abuse because of a brainwashing experiment which took place nearly a decade ago. The attempts on my life and discrediting of my character began to speed up after I wrote a document describing the people, places and events which occurred. I even went to a local law enforcement official and described in detail the events which occurred, and from what I can gather he was told to not investigate the allegations. Doing my own investigation, I documented the people involved by taking photographs of them, located the building (which was torn down and turned into a baseball field), tried to locate records on the park (when it was built etc.), asked questions of law enforcement officials, directors of parks and recreation, internal affairs for the dea and fbi and the only response I have ever gotten is "stop looking into this". Since all of my own investigations have led to dead ends I believe the people involved in brainwashing me back in 95' have employed the use of a device making use of a federal patent application number 20020162942. I have a hard time every day coping with life because of this. My friends and family don't want to talk about it because I get so frustrated trying to explain everything.

Ed Kats and Family

Ed Kats and his son Jay received brain implants during supposedly routine operations. They have a clear xray of two of the devices. Two major hospitals on the San Francisco Bay Peninsula in the state of California, USA were involved. Surprisingly, one of them did the revealing xrays (must be differing factions there?). Ed sent me their account and appeal in an email, presented here. He would like the implant program to become common knowledge.

Kris

I began hearing voices about a year and a half ago along with having body convulsions, street theatre, and memory lapses. They tell me they are taking my life away and that I am a part of a human experiment. My tongue moves on it's own in my mouth having

spasms which the doctor said means I have something on my brain stem, however they found nothing irregular.

Linda Lalla

I was the subject of non-consensual human experimentation. I am told by Cheryl Welsh, President of an Organization against the abuses to human rights, that Sharon Shea went through something that paralleled what I went through. I have been unsuccessful in contacting her for about a year. I tried once again to contact her tonight, and was not successful. The technology that I have witnessed has astounded and frightened me. God bless us all, as the way that I have perceived everything since my experience on May 21, 2002, has been altered forever.

John Lambros

John Lambros, a stockbroker and international businessman, was arrested in Brazil and illegally denied bail. He was then used in the CIA's mind control brain implant program. Now in Leavenworth Prison in the United States and crippled by the remote-control implants, John has a web site which hosts his account, a plan for legal action, documentation of his struggle, and sections about several other victims not listed here at the MCF. The first link at the site is the account - "Congress Asleep at the Switch Again." This includes images of documentation such as medical reports from MRI scans showing implants.

Layne

It has been a long and lonely 5-7 years as a test subject to a division of government mind control. I only know of the last 5 years, but I am fairly sure they were watching and observing long before they decided to move to a new phase and transmit their voices to levels that could be heard.

Jane M

Everything in my life was pretty normal, until one evening, in Oct. of 1994, when the onslaught of my ritual abuse began. All at once, I started hearing voices, commenting on what I was doing at the time. This grew into so much more than your basic "hearing voices". 2 movies come to mind, when I think of how to describe this part of my life: "Being John Malkovitch", and "The Perfect Storm". The first, because like John Malkovitch in the movie, I am also being made to share my senses and even my thoughts with a select few, who have decided it would be wildly fun to try to 'drive me crazy' this way.

John MacDonald

I am involved in a hospital signals implants case in Nottingham about a left palate brain transmitter device with a connecting socket micro receiver. This is a two-way control and interrogation system in my upper jawbone. It is a surveillance, control and interrogation system.

Pam Mata

My name is Pam. I have been a victim of satellite tracking by the U.S. Government.

I have been through the "skits" at work. They used behavior modification to fire me finally. They harassed me unmercifully with trigger words. I'm now on disability because of it. There are several local perpetrators that keep me in line with triggers. I have been through them tearing up my cars and sneaking in my house. They are using brainwashing techniques to keep me in line. The media is involved. Subliminal TV messages were prevalent.

William MacIntosh

During my 20+ years of working with the DOD and DOE I've had the pleasure of operating, maintaining, and repairing many a varied electronic device. The BQN3 sonic beam had a "pencil profile" (~1deg) and the system had an excellent accuracy even at the extreme depths of the Pacific Ocean. It seems that the modern descendant of this technology is now being used against the civilian populace with a total disregard of human rights. Since 1990, when I was working for Stanford Linear Accelerator, I have been literally tortured by some organization with the use of this exact technology.

Martin C. Mack

Upon checking into a hotel, Martin C. Mack found that the tenants next to him were doing remote electronic torture experiments, and picked him as a guinea pig. He moved, but the tortures have followed him. Martin experiences a lot of bodily tortures, plus exquisite reading of his subvocalizations. He has managed, through the tortures, to compile a summary and technical description of his experiences.

Mesquite John

I am the victim of surveillance and mind control. The operators/controllers beam various thoughts into my mind. My home is bombarded with electronic energy, and electrical appliances and the phones often malfunction. I have sometimes been followed in cars, but not recently as far as I know. I have no special information and am just an ordinary guy.

Michael

I have been a victim of NSA mind control for over 8 years. I am currently seeking legal help from Harvard University. And in addition I have been injured, slandered and abused in public.

Harrison Deckard

Recent victim of mind surveillance in San Francisco, though suspect I've had light surveillance since 1979. Beginning July 2003 I've been experiencing the "voices," and while there has been no overt control per se, there has definitely been monitoring and reporting. Can't say whether or not there are implants, etc., but superior (though commercially available) technology is definitely at work -- including micro/radio-wave thought interpretation (though this may possibly be a byproduct of hypnotic suggestion rather than reality), electronic tracking, and audio/visual surveillance. I believe I'm more a victim of amateur, highly technical hypnosis and "implant hoax" rather than classic government mind control, though many of the methods used follow an MKUltra design

(hypnosis, drugs, post-hypnotic suggestions with triggers, long range reflex lie detection, etc.).

Daniel Moore

My name is Daniel Lee Moore and I am a non-consensual experimentee of electronic surveillance and mind control technology by the Department of Corrections in the state of Delaware. I ask for anyone who reads my account to pray for me because I am engaged in a war in Delaware and I need all of the prayers that I can get to strengthen me so that I can continue. I know that there is strength in prayers or else I would still be incarcerated and unable to tell others of what is occurring here in Delaware.

Lynne Moss-Sharman

Lynne is one of the founders of ACHES-MC: Advocacy Committee for Human Experimentation Survivors.

Pat Mougey

Pat Mougey is a working professional who, in her account, describes how she began to hear a never-ending barrage of psychotronic voices. Her late mother was also targeted. Included is a detailed account of the outrageous things they did to her appliances!

Susan Mullen

Earlier this year Susan began experiencing such mind control techniques as electrification of her head with an associated "twanging" sensation and hearing clicks in her home when no one else has been there.

Robert Naeslund

"Luckily" (for his credibility), Robert Naeslund has actual proof of being implanted with brain transmitters by the CIA and Swedish authorities. [Click here](#) to read his account and doctor's report, including a description of bio-medical telemetry, a wireless connection between a person's mind and a remote computer (usually without the subject's consent).

Joyce & Earl from Oregon

Joyce and Earl tell their account about being the victims of psychotronic assault since 1994. Their hope is that "other victims will come forward and print their account. All victims must rally together and make the crimes being committed against us public knowledge." Their account tells of broadcasting, which began when new neighbors arrived next door. They speak of what happened and of the frustration when no one would help them.

Mary Lou Nelson

Group coercion, street theater and staged events are the primary mind control methods of this enterprise. I have also been isolated, drugged, hypnotized and subjected to psychotronic abuse. Mail tampering and telephone wiretaps are common. I have also been subjected to staged fatal and non-fatal accident attempts.

Robert Pollack

Robert Pollack's account tells of continual lambasting by psychotronic voices via electromagnetic implants. He says:

"These verbal assaults are made possible through an implant in the auditory canal and are transmitted directly to the brain through the auditory nerve center, with the result being a very positive and yet faint voice."

This sounds like an adaptation of the Neurophone. As is their usual way, the "controllers" have destroyed Robert's personal and professional lives.

Rick & Tina

Rick and Tina's account tells of their experiences as victims from E.L.F. & or microwave harassment, since 1996. Both would like contact with other survivors or victims of E.L.F. and Microwave harassment.

Larry Howard Roben

I'm a victim of company torture from the very top levels of gov't, so the programmers tell me. They use all types of different techniques on me. Right now I have an acoustic head ache. I was recently hit with non-lethal weaponry in my truck. It felt like it could have knocked me and my truck dead in my tracks. A few days later a blast of energy almost tore my head off. I have almost fifteen years of torture stories to tell. The company made me aware of their presence in my early twenties. Started torturing me in 1990 and they have not let up. The torture techniques change, they have destroyed my life. I recently wrote over forty letters congressional sub committees with only Bob Filners office saying they could not find anything on mind control or human manipulation. It was a simple letter asking for information under the freedom of information act and being a united states citizen. I asked this of any gov't agency and private sector.

Scott Robinson

This is a bit difficult to put in to words but the basic story goes like this:

I am a 43-year-old Engineer working for the Boeing Co for sixteen years. No medical or mental illness and in excellent health. I have no criminal record. And would provide any credentials upon request. Read more of Scott's account

Ronald Roose

The retaliation consisted of organizing other employees to harass him, directing electronic weapons on him, delivering chemical and biological poisons into his food at home and onto his workspace, and interfering with all the registered mail he sent in relation to his claim. They even poisoned his cats. Eventually the electronic weapons had him disabled. Ronald would especially like to get in touch with other postal victims. I received this on 11-06-2003:

"while he was staying at a hotel in Paris, in July of 2002, he conceded to the horrific pain and took his life"

David W. Roscoe

In late November 2001 I began to notice some strange and unpleasant new problems in my life. I had trouble relaxing. I was not sleeping well. I noticed a high pitched hiss in my ears. Over the next couple of weeks the problems became worse. I could get almost no work done.

Yvonne Frances Ross

I have been harassed daily with non-lethal weapons, by vicious and annoying surveillance, and I have been harassed in some ways that are not well known. I have been mostly victimized by local harassment.

Bill Rosser

Bill Rosser's account is like quite a few other victims of electro-magnetic "less-than-lethal" weapons controllers. They started off subtly manipulating him and having provocateurs terrorize him, and finally came out and tortured him with the beam weapons. As usual, Bill finds himself cut off from people by the incredible appearance of his account. Bill began to understand the project as it progressed. He sees it as "a Holocaust style psychological and brain study as well as scientific experimentation on humans with this new technology and general politically motivated human rights abuses." Bill writes:

"The survival of American democracy and of democracy on the planet depends on the people quickly identifying and responding to new threats to our liberty. This new weapons technology must be understood for the threat it is; probably greater than the threat of nuclear weapons because of the people's present lack of ability to detect their abuse."

Contributed on behalf of Cary Adcox

In his account, Cary Adcox, a technician, is prevented from finding employment by, he suspects, government agents working behind the scenes. He feels that he has brain implants due to the close interfacing of himself with the very minds of agents, and to xray results. Besides physically torturing him and modifying his thoughts, the controllers seem to be interested in going through his engineering knowledge. Cary has been aware of the controllers for five years. Moving to Europe did not help, as they followed him, the same experience that others have had. Cary Adcox added the following article: The End of The Constitution

AJH has been the subject of directed energy weapons for 10 months as of 9-22-2002. There appears to be employer and landlord cooperation, with the harassment and surveillance continuing. Marla Allison

While living and working in Europe approximately 1 year ago, I became aware and have come to understand that I am being monitored by some sort of tracking device. I have an incredible account to tell but more important to me is how I can get help for what is happening. I would also be interested to hear from others who have similar experiences around RMN or EMF.

Aratadude

Lance - electrical engineering and information technologies specialist. If you think you are afflicted with "artificial ESP" or hear voices and even talk to voices, I want to hear about your experience. I have been afflicted with this technology for about 3 years that I am aware of and who knows how long before that. I hear a noise constantly like people describe as the Taos Hum. I also hear some person modulated over that hum or noise more or less constantly.

Ramona Ayala

Hi, my name is Ramona Ayala and I live in Camarillo Ca. I have been a target of microwave abuse for four year now. I was very active in my community with human rights. In 1993 I was a honored with the Latino Leadership Award. However, now my life has changed considerably since the torture of being zapped with this energy. The constant zapping of this energy has debilitated to the point of isolation from my work. I believe this is what they intended to accomplish. It very difficult to continue a normal life with this torture. I have a lot to say about the horrors these people are capable of doing. I would very much like to get in contact with as many people experiencing this torture and communicate information.

Eric Bazan

I've recently become aware of 'cause stalking' and e-harassment techniques. I feel I may have been (and still am) a victim of both. I'm furious about it.

Steve Bratcher

Steve Bratcher was a government agent in Orlando, Florida when he and a friend volunteered for a "Top-Secret Experiment in which audiograms and biosurgical procedures were to be conducted on them." In fact, unspeakable remote-controlled tortures were conducted and the experimentees held against their will.

Steve Bratcher, long term researcher in mind control (after it was used on him by his employers, the CIA) checked into the hospital last Wednesday (April 17, 1996) scheduled for surgery for prostate cancer. Brains cans also showed a brain tumor and what may be brain implants.

Tannie Braziel

Bruce

I've been living in hell for 7 years, as too many others are as I have found out!!! I've been electronically harassed for 7 years, these (people?) have continued this relentlessly for this period. They state the only way they will stop is for me to die. These stalkers have used to the best of my knowledge emf toys, and, many times driven me the brink of suicide.

Shawna Burkhart

My name is Shawna Burkhart I am also a victim of mind control. I have been dealing with this for the past four years. I am very scared, and hoping each day that it will be over, but it does not seem to stop. I have been tortured, and I have also lost almost everything I have had. At least I know now that I am not the only one out there that this has happened to.

Mike Cab

My initial torment started in 1977. My initial audible voice I heard while sitting in the dentist chair, in 1977, just after having a tooth filled with amalgam (silver mercury filling). I immediately confronted the dentist, who called my mother (I was 17 at the time), who immediately sent me for a psychological evaluation (schizophrenic). Yes, instantly discredited and invalidated me and my claims, suspicions, etc., by having me mis-diagnosed.

Lee and Farren Carroll

Driven from their home, forced to live with relatives, and all the while being tortured by electromagnetic means, Lee Carroll and her daughter Farren believe they know the identity of the perpetrators.

Guy Chapman

My experience of this unbelievable phenomenon has been going on for 15-16 months. It includes: 24/7 surveillance (my family was followed 100 miles away from home on vacation), tapped phones, ringing ears, shock waves, electrical shocks, tree climbers, defamation of character, the list goes on. I am working on a detailed account.

Blanche Chavoustie

Blanche Chavoustie is the USA contact for ACHES-MC, the Advocacy Committee for Human Experimentation Survivors - Mind Control.

Chet

I have been subjected to mind control for approximately 2 years. I have survived through practically every form of harassment these people can subject me to. I would like the world as well as the public in this area to become aware that there is people who can and will use techniques to not only use mind control, but have no care for what they do to individuals who they have harassed. I have a sound phenomena that goes on or around my trailer where I live. The sound phenomena gives the appearance that I am hearing voices. The distortion usually happens from radios, my computer, or television. The voices I hear from time to time are of different people I have encountered or claim to be friends in the area I live.

Mark Cohen

Mark Cohen's account tells how his promising studies in Sociology at the University of Wisconsin-Madison were interrupted by the CIA. Impeding his studies and employability, the psychotronics brigades made Mark a pincushion for their remotely beamed bodily experiments as well as their mind attacking holographic dreams.

Dave

I am a victim of a brain implant. The people using this device on me are very cruel people. Accusing me of acts that I didn't do and threatening me to execution or they are going to kill my family. They have my house bugged, they know everything I think and do.

Dee

The harassment of Dee and her husband and children began with sounds and voices coming from the walls. This intensified to include intrusive programs replacing radio shows [this has been my experience too - ed.]. Dee and her husband left tape recorders running and have tapes of break-ins. The intruders poisoned them with chemicals, sabotaged their cars, wired their electricity to an unknown draining circuit, borrowed items, and changed combinations in locks. Finally one child developed serious unexplained rashes. Dee had to quit her job, and the authorities were no help, separating them from their children for a time.

Samir

I have been the target of their "microwave/voice" technology for two year or more, to this day. In any case, I have been subjected to hundreds upon hundreds of insults, various nights they used that device to keep me up all night, using the device to have citizens in Davis insult me in my environment, using the device harass me in my own room or anywhere in Davis, and the list goes on and on. This is a very brief account, and I could probably write for a hundred pages about what I have been through. For two years I was harassed and/or the target of this device in Davis as a UC student on almost a daily basis, and now I have moved to the East Coast. The last few weeks of September of 2003 here

today, one of their favorite things to do has been to use the device to distract me while I am attempting to study for my classes. They intentionally use this device to distract me, so I will do poorly in my classes and wreck my grades. W. Samadhi

In the United States today, there is a covert war going on. The war involves the use of covert weaponry upon an unprotected civil populace. Psychological operations, directed energy, and incredible mind machine interfaces are being used on U.S. citizens, as well as fear.

Jeremy Schott

I awoke to a woman's voice in my head telling me that I needed to be "controlled". From that day since, I've had a ringing in my ears. People/person were seemingly attacking/reading my thoughts and "commenting" on everything that I did/do. The volume of the ringing has, in the past, been turned up so loud that I thought my ears would explode.

Robert F. Schuler

I believe that a law enforcement agency is harassing me because I lived next to one of their agents and witnessed him and other 'tree people' using mind control to rape another neighbor.

Selli

I am still unsure of exactly what the procedure they performed on me was, but I know these two truths: I can sense a steady pulsing in my left temple, and whenever I attempt to break away from the orders given me by the government, I hear a voice screaming in my head, ordering me not to disobey.

Shelly

I have recently become aware that I am a nonconsensual participant in a mind control (?) study in Columbus, OH. I am currently experiencing 24 hour harassment through synthetic telepathy and precision manipulation of body parts - I have many of the ELF effects listed on Dr. Richard Alan Miller's website. The unknown researchers have carried out skits involving my workplace, a large employer in the city of Columbus. They have monitored me in Columbus and my parent's home in Northern Ohio. I just want to find a place to live without harassment and monitoring. Please let me know your opinion soon. I need to find a place to move.

Rev. Bob Shannon

Rev. Bob Shannon tells his account of how, in the sixties, he, after becoming upset with the military while a serviceman, was subjected to mind control testing which has left him disabled. Typically, his attempts to get help through veterans' services have been rebuffed.

Shannmd

A life full of relentless coincidences, seemingly endless observance of my every minute I am conscious, people roll playing everywhere around me when I am out in public, the near surrender of life, doubt in my own sanity, Finally unable to trust anyone.

Laurel (on behalf of Sharon)

I met Sharon recently at a meeting about the Patriot Act, where she got up and asked if any one could help her with her implants. Since I had recently read Jim Keith's excellent book "Mind Control/World Control," I approached her afterwards and asked her about her case. She showed me some of her burns, and we exchanged phone numbers. She believes she has brain, cochlear, and other implants. From what I've been told: In Oct. 2001 Sharon went to the hospital for a knee operation. A couple of weeks after the operation, she started having problems with her equilibrium and started noticing a buzzing noise that gradually got louder. She also started noticing burns on her feet and eventually on other parts of her body. She would often have sudden, intense pain in the places with these burns and also in her head.

Joan Siegemund

Joan Siegemund's account begins with her mother being drugged in order to steal her inheritance. When Joan began to protect her mother she experienced burglaries, phone interference, and psychotronics. She says:

"Mind control was preceded by strange kinds of vandalism calculated to induce wonderment and terror. This was followed by micro and other waves that were traceable by Gauss meter to a neighbor and presumably to a more remote unspecifiable source."

Duncan E Simpson

I have been under attack for about 11 months now and have had muscles quakes, itching, hot needles, bee stings, eyes were made to turn red as if infected, they even found a way to enter my dreams and the sensations that bugs are crawling on me.

Steve Smith

Steve was incarcerated at the Oak Ridge mental hospital and received sadistic treatments which may have been part of a CIA experimentation program. After complaining to Canada's Health Professions Board, the board described the treatment as 'not serving the public interest.'

Margo Tilton

Margo Tilton writes that she has been victimized by neuro-electromagnetic technology since February 1992. The perpetrators have caused her the loss of her children, her privacy, and her dignity. She experiences physical pain, altered moods, and an unending stream of words meant to ridicule, degrade and torment her on a 24-hour basis, as well as a host of other effects.

Steve Tueting

Steve Tueting writes that he has been a target of psychotronic beams for a long time. They cause him physical pain, with many miserable symptoms, and keep an abusive running dialog going with him via the mind-penetrating signals. On top of all that they jam and alter his moods.

UltraSonic

Can a secret police force exist in America? Never! I would have given this answer before September of 1998 but not now. A secret police force operating above the law, doing illegal surveillance, and acting as judge, jury, and executioner exists in America. This secret police force consists of private American citizens who have access to extremely advanced surveillance, harassment, and non-lethal weapons technology.

Vicki from Michigan

Vicki from Michigan is a professional mother of two young boys. Over a period of time they began harassing her over the radio and commenced to ruin her life. The experimenters harassed her verbally, altered her moods, physically tortured her, and hurt her mental capacities.

Eleanor White

She reasons that the general public, if motivated to demand disclosure and control of mind weapons and their use on human targets, is the only entity which can stop the huge technological, political, and economic lead possessed by the mind control perpetrators.

Jim Whittle

Having worked in high-tech, Jim is able to intelligently speculate on what sort of systems must be in use to target him and the other victims of psychotronics. He also makes appropriate comments about the social control involved, and the attitudes of targeted individuals.

John Williams

I moved to an apartment complex in Santa Clara, California in the mid-1990's. Apparently several residents had somehow acquired portable radar sets and were using them occasionally even at that time. Many residents were public employees such as fire, police, or military. In late 1997, at least one of them began harassing me by irradiating my apartment. I experienced skin sensations (creeping; crawling) and electric-shock like pains. I visited the Santa Clara police to complain about this. After much argument with "we don't want noone to make no waves" desk personnel, they finally opened a case on the problem. Four other victims seemed to have the same problem: "Heveab", David W. Roscoe, William McIntosh, and Peter Wolfe.

Michael Williams

Michael Williams was a political activist and musician who worked with the assassinated John Lennon. In his account, an E-mail to Lennon's son, Michael tells how he has been destroyed by the FBI; he feels that Lennon was killed by a programmed assassin.

Many psychotronics victims, including myself, have had their pets killed by remote beams. In Michael's case, the FBI came to the remote mountain home in which he and his family were living and shot his young daughter's puppy in the head, then brutalized the people.

Peter Wolfe

My name is Peter Wolfe. I live in San Francisco and I am being targeted with electromagnetic weapons used for mind control, since about September, 2000. My case may be a little different because I paid \$25,000 to someone who may be a (street?) perpetrator, Randy Zelinka (see details below). Currently I am filing a civil lawsuit against Randy Zelinka and his business Zelinka Electric in an effort to recover the \$25,000 and also make a public record of what happened. The case name is WOLFE v. ZELINKA, San Francisco Superior Court Case #411666
